When my son was racial profiled, right in front of his own home.


In February 2012, I read about another teenage boy who was also racial profiled in his own neighbor hood by a security guard.

We may not refer you directly to another attorney. We always advise people to check with family and friends to determine if they know of an attorney with whom they feel comfortable. If this is not possible, the Lawyer Referral Service of the Knoxville Bar Association, at 522-7501 may be able to help you. They will schedule a one-half hour appointment for you with a lawyer who works in this area of law free of charge. If you 9-12 choose to hire the attorney, then you would be responsible for any fees required by the attorney. You may also check the yellow pages under attorneys.

We will not be providing further help with this problem. If at any time you do not agree with a decision of Legal Aid of East Tennessee, you may file a grievance. To do this, contact our receptionist, and she will mail the necessary form for you to complete and return to our office. The grievance will be reviewed by our Associate Director, and a further decision will be made.



I'm filing a written complaint on the behalf of my son Diamond Fields. For years my son has been harass, racial profiled, maliciously falsely accused, and bullied by The security officers employed by Centurion security agency here in Knoxville TN. Big Oaks Apartments has fired them several times, and each time has kept them on pay roll. The security officers of Centurion Security Agency, their only job is to put innocent people in and jail or evicted innocent people. They can comment murder and big oaks apartments will still keep them on payroll.

On **February 2. 1008 around 9: 30 pm**, two white security officers of Centurion Security agency saw my son walking home from a friend house. They both physically assaulted my son; they both took turns beating my son, while he was still on the ground. This police brutality did just end there. They both told maliciously lies on a police report and had my son arrested on false charges. They never did read him his Miranda rights when they put the hands cuffs on his arms and put him in jail.

On **February 15, 2008** Big oaks once again fired the security officers of Centurion Security agency. And on **April 8, 2008** Big Oaks Apartments has hired them back. Thanks for taking time out of your busy schedule to support my discrimination complaint against the security officers of Centurion Security Agency, working for HUD section 8 housing at Big Oaks Apartments.
